## Introduction

If you have been injured in the last three years in an accident which was not your fault, you may be entitled to compensation for your injuries and for your losses. Many do not claim through ignorance or a fear of the costs involved.

## Who can bring a claim?

You can-providing the accident was someone else's fault, it was the cause of your injuries, and it happened within the last three years (or up to your 21<sup>st</sup> birthday if you are 18 or younger).

## How much will you get?

This depends on the severity of your injuries, how badly you have been affected on a daily basis, and how long your recovery takes. You will be compensated for the pain and suffering you have had, and also for all losses including past and future loss of earnings resulting from the accident. If your injuries require someone to care for you, we can get compensation for the cost of a carer.

## How long will it take?

This depends on the extent of your injuries. Once your injuries have stabilised we will be able to calculate your compensation. This will be aided by expert medical reports. Wherever possible we will negotiate the settlement of your claim without going to court. Only 2% of claims actually go to a hearing. If there is a hearing, we will ensure your claim is brought promptly and is dealt with by the courts with the least possible delay.

## What are the costs?

It need not cost you a penny. You may have legal expenses insurance in which case your costs will be covered by your insurer. Otherwise we will consider with you a no-win no-fee agreement backed by insurance to protect you against paying the other side's costs if you lose. But we have a high reputation for success and we look to you keeping all or as much of your compensation as possible. We offer a free initial consultation to look at your claim and advise on your prospects of success.

## What else can we do?

We can give you advice on how to ensure your compensation money is put to the best use.
